On behalf of the CAB Board, we continue to be very proud of the dedication displayed by staff and volunteers who work at the Citizens Advice Bureau in delivering important services to the Western Australian community since 1963.

With a **Perth office** and nine branches located in the metropolitan and the regional areas of Bunbury and Busselton, CAB's services remain focused on information and referral plus our value for money legal and mediation advice.

Our **Bunbury** branch was established in 1974 with **Busselton** following soon after in 1975. Our metropolitan branches are located in:

Our sought-after services include Information and Referral service, where the public can call on subjects ranging from neighbourhood disputes, restraining orders, family and property matters, our mediation and legal services and criminal injuries compensation.

Our legal service is focused on providing legal advice and documentation primarily in Wills, Enduring Power of Attorney and Guardianship, Probate, Letters of Administration and Family Law, while our mediation service has 12 accredited Mediators who can assist with pre-mediation and mediation on subjects as varied as neighbourhood disputes to family visitation arrangements.

We also have great partnerships with organisations such as the Justice of the Peace as well as Legal Aid WA, where we host their virtual services in many of our branch offices, proudly supported by our volunteers. This service is in addition to our own virtual legal advice services offering family law appointments on a monthly basis at our Busselton, Rockingham, Fremantle and Kwinana branches. We also continue to be supported by visiting lawyers in our Perth and Joondalup branches covering legal areas of criminal, family and civil law.

This is a busy time in our organisation with a number of branch-related annual meetings and branch events to mark our 60th anniversary with some important local stakeholders who have been long-time community supporters of our branches. We are also leading up to our Annual General Meeting scheduled for 16 November 2023.

As an active independent non-for-profit in the community services sector, we are indeed fortunate to have the support of the WA Department of Communities and Department of Justice. In addition, this financial year our Mediation area with a focus on facilitated dispute resolution has also received funding from the Law Society's Public Purposes Trust. We are very grateful for our funding that benefits so many Western Australian's including many in vulnerable situations.

This particular information session provided participants with knowledge about the services CAB provide regarding EPAs, EPGs, Probate, Advance Health Directives, Family Law matters and more.

PARTNERSHIP HELPS VULNERABLE ACCESS JUSTICE

In addition to a Perth office, the Citizens Advice Bureau operates nine branches in Western Australia including the regional locations of Bunbury and Busselton.

Since 2019, we have partnered with Legal Aid WA to grow and bring additional services to vulnerable Western Australians. Our branches host Virtual Legal Aid Appointments in the areas of civil, family and criminal law.

Our partnership aims to increase access to justice for vulnerable West Australians and by working together, we are able to reach people across the state.

CAB branches involved in this service include Busselton, Mandurah, Rockingham, Kwinana, Fremantle, Armadale, Midland and Joondalup. These branches provide the services of CABs trained volunteers to run and operate Legal Aid WA's virtual office appointments.

In addition to visits by CAB solicitors to our Midland, Joondalup and Armadale branches, CAB also operates virtual legal appointments in the area of family law at the Busselton, Fremantle, Kwinana, and Rockingham branches.

In the 2022-2023 financial year, our partnership with Legal Aid has directly resulted in helping 451 individuals with family law advice, 229 individuals with civil law advice and 23 individuals with criminal law advice at our branches.

COMMUNITY LEGAL EDUCATION: Corinthian court and keith Simpson Village

During August, our Principal Legal Officer Ms Samantha Gomez and Solicitor Ms Jiji Croy attended the Corinthian Court and Keith Simpson Village to deliver a presentation on Wills, Enduring Powers of Attorney, Enduring Powers of Guardianship, Probate and Letters of Administration.

The audience was very engaged in the seminar actively asking questions and posing multiple scenarios to discuss with our team. Feedback following the seminar was that the information provided had been interesting and informative, but even more importantly, made some of them realise it was time to update their Wills!

CAB values the opportunity to provide community legal education whenever possible as it is only through access to the law that we can truly have a just society. Some of the areas which we focus on include but are not limited to Wills, EPAs, EPGs, Letters of Administration and Probate.

We pride ourselves on taking the law to those who need it the most. Our focus therefore is not to present at highly regarded conferences to educate other lawyers with our specialised knowledge or to grow our individual profile within the legal profession.

Instead, we take our presentations to the suburbs where ordinary individuals reside who may otherwise not have the opportunity to learn about our areas of law and empower themselves with that legal knowledge.

MEDIATION: MEET THE MEDIATION COORDINATORS

CAB operates a Mediation Service with 12 trained and accredited mediators, nine of which are qualified Family Dispute Resolution Practitioners. Our mediators focus on family disputes, such as parenting and property, as well as community and small commercial business related matters

To date, CAB partners with the City of Joondalup, the City of Kwinana as well as the City of Swan regarding a variety of community-related disputes.

CAB is pleased to announce the results of its annual Customer Perception Survey undertaken in May across Perth office and nine branches located throughout the metropolitan area, and regional centres of Bunbury and Busselton.

Although CAB collects feedback from our customers via a number of sources over the year, our Customer Perception Survey provides feedback on the quality of our services, as well as customer service satisfaction. During May, Customers were asked to rate our services based on how strongly they agreed or disagreed with questions relating to CAB.

Aggregating the results from agree to strongly agree, 94% of CABs customers would recommend our services to other members of the community, 89% would continue to use CAB services again, and 96% found CAB services helpful.

CAB is also proud to consistently receive high customer satisfaction ratings, with 97% of our customers agreeing and strongly agreeing they were happy with the services received from CAB.
