Probate is the legal process of getting permission from the Supreme Court of WA to carry out the terms of a Will.

If a person dies without a Will, the law sets out how their property will be distributed after all debts have been paid. Without a Will, it may be hard to work out who should apply for permission to deal with the deceased estate. In situations like these Letters of Administration may be required.
